

ORDER OF DISMISSAL




Dear Ms. Turner,

You will recall that the above cases are consolidated for hearing, and scheduled for January 25, 2006. There are two developments I need to advise about. The first is that two of the four grievances (Paar and Albright) have been resolved between the parties. The other two grievances (Hollis and Walkowiak) appear likely to go to a hearing.

The second item of information is that grievant Hollis has indicated she would prefer Mr. Dillon not sit in judgment on her grievance because of his close relationship with Ms. Gzyn who, we understand, will be an important witness for the State.
